

**DESCRIPTION OF CONTEST:** Alive in Roswell Town Square Passport program is designed to gift prizes for participating in vendor interaction.

**ELIGIBILITY:** This promotion is open only to individual residents of the 50 United States and the District of Columbia, 18 years of age or older at time of entry. Employees of City of Roswell and Vendors, and their immediate family members and/or those living in the same household of each are not eligible to enter or win. All federal, state, and local laws and regulations apply. Void where prohibited by law.

**LIMIT:** Each participant may enter the drawing (1) time per event. Any attempt by any entrant to obtain more than the stated number of passports/entries by using multiple/different, identities, registrations, or any other methods will void that entrant's eligibility and that entrant may be disqualified. The City is not responsible for lost, late, incomplete, invalid, unintelligible or misdirected registrations, which will be disqualified. In the event of a dispute as to any submission, potential winners may be required to show proof of identity.

**HOW TO ENTER:** Promotion begins 5:00 pm. Eastern Standard Time ("EST") on each event date at Town Square Park, 4/21, 5/19, 6/16, 7/21, 8/18, 9/15, 10/20 to 8:00 pm 2022. Participants can pick up a Passport at the venue and are required to visit at least 15 of the vendors at the venue for that given date. Each vendor will verify participation by applying a vendor sticker onto the participants Passport. Participant must return their passports to the appropriate submission box at the venue before end of event.

**WINNER SELECTION:** A random drawing will be conducted on or about the day following each event, from among all eligible entries received. Random drawing will be conducted by a representative of the City of Roswell whose decisions are final. Odds of winning will depend upon the number of eligible entries received. Winners will be contacted by phone and/or email, and their name and/or photo may be posted on City of Roswell social media accounts and website. Prize may be awarded to an alternate if potential winner is deemed ineligible or does not respond within (7) days from initial notification. The prize must be picked up in person by the Entrant, at Roswell City Hall 38 Hill St. Roswell GA 30075. The prize will not be mailed and must be picked up in person. Failure to do so will result in disqualification and the selection of an alternate winner. Prizes are non-transferable and are not redeemable for cash. Recreation account credits expire after (24) months from date of issuance.
